VIII. Academic Senate Report – Serena Ott

- A. <u>Senate Executive Board</u> The Academic Senate Executive Board has met once since the last FA Exec meeting. Lance Heard will serve as Academic Co-VP for the Summer. The Senate Executive Board will meet Thursday, August 22 which is the day before FLEX Day.
- B. <u>2nd New Faculty Seminar Facilitator</u> Since there are more than 40 new faculty hires, Joan Sholars met with Chisa Uyeki and Dr. Scroggins to propose an additional New Faculty Seminar Facilitator be appointed. A MOU has been signed agreeing to the addition of a 2nd New Faculty Seminar Facilitator.
- C. <u>Additional Faculty Assignments</u> A proposal for a Sustainability Coordinator Reassignment is under review in AMAC. Joan has also asked Senate for an Assistant Accreditation Coordinator position.

IX. Adjunct Faculty Committee – Linda Chan

- A. <u>Adjunct Faculty Advisory Committee</u> The Adjunct Faculty Advisory Committee met June 13, 2019.
- B. <u>Membership Engagement</u> The committee discussed how to get more adjuncts to join, how to get current members more engaged, how to build camaraderie among full-time and part-time faculty, and where to find or strongest full-time advocates.
- C. <u>Proposed Workshops</u> The following were proposed workshops: how to get a full-time job; how to get paid six hours of personal growth incentive; how to get unemployment.
- D. <u>Department Issues</u> The issue of the English department having elections without any parttime faculty input or participation was discussed.
- E. <u>Adjunct Faculty Committee Membership</u> The issues of how to replace members was discussed. Also addressed was how to reduce the restrictions on meetings and place a maximum and/or minimum. A possible solution is to change to a stipend amount per semester.

XI. Insurance Committee

The purpose and function of the Insurance Committee was discussed.
