 - The Committee is working with CTA CSO Representative Wendy Lockhart and WestEd group to develop a plan that CTA will be able to support.

c. Treasurer

In Treasurer Michelle Nava's absence, Director Maya Alvarez-Galván presented and distributed the most recent <u>financial statement</u>. Maya noted that \$15,000 of conference expenses for the July's NEA Representative Assembly are being funded through the POD Conference and Travel funds.

V. Closed Session

The Executive Board discussed and advised on the current state of negotiations and actions to support FANT. Concern was expressed about the continued lack of progress in negotiating the

2023-24 faculty contract and about the District's chronically slow response time in countering the FANT's proposals and counterproposals on several reopener items, including Articles 7 and 8, Salaries and Contract Employee Benefits, respectively. Contract negotiations are more than one year behind. CTA Liaison Robin Devitt provided an overview of laws and procedures pertaining to collective bargaining under the Educational Employment Relations Act (EERA). Robin is available to provide training to the Executive Board on matters related to collective bargaining. The next negotiations meeting with the District is scheduled for Monday, July 1, 2024.
