V. Negotiations – Herschel Greenberg

FANT and the District are nearing agreement on the extension of the adjunct office hours pilot through spring 2026. If agreement is reached, it will be the first Tentative Agreement of the 2024-25 negotiations cycle. The district has stated its desire to close the 2024-25 negotiations soon yet is refusing to come to agreement on proposals that have been on the table for several months. Progress in negotiations for the 2024-25 cycle continues to be slow, with the district not willing to agree to much of FANT's proposals. The district's counterproposals reflect its unwillingness to fairly and equitably compensate the faculty for our work or to negotiate the State monies available to the district to offer employee-affordable part-time health benefits.

- Resolved, that the Mt. SAC Academic Senate and Faculty Association jointly reject any external or internal attempts to restrict curriculum, undermine shared governance, or narrow the scope of faculty expertise and inquiry particularly those that target DEISA+ related efforts; and
- Resolved, that this resolution be communicated to the Mt. SAC President and CEO and the Mt. SAC Board of Trustees as a united expression of Mt. SAC faculty's defense of academic freedom, inclusive education, and professional integrity.

A motion was made to suspend the rules to act on the item today (Christ) and seconded (McFarlin-Stagg). The motion passed: 33 in favor; 8 opposed.

A motion was made to adopt the joint resolution, contingent on Academic Senate's approval (Christ) and seconded (McFarlin-Stagg). The motion passed: 37 in favor; 3 opposed; 5 abstained.

A motion was made to extend the meeting until 1:15pm (Alvarez-Galván) and seconded (Landeros). The motion passed. New Business items a. through d. were addressed.



Why is CTA hosting this rally? We will demand that federal elected officials protect and increase funding for public education, keep our schools safe from ICE raids, and commit to voting NO on closing the US Department of Education.

- To keep schools and colleges safe places for students to learn.
 We are demanding that the federal "sensitive places" rule be restored. So many of our community college students are immigrants or part of immigrant, mixed status families.
 We're standing up to protect them and ensure a safe learning environment.
- To stand up against the dismantling of the federal Department of Education programs. Among other things, the Department of Education oversees Pell Grants, federal student loans, work-study funding, and other forms of financial aid that community college students rely on. The Department enforces Title IX and other civil rights laws that protect students from discrimination and ensure access to a college education. The Department of Education also recognizes accrediting agencies like the ACCJC to ensure they meet certain standards. This recognition allows the colleges accredited by ACCJC to be eligible for federal financial aid.

Grievances and Other Representation:

- The district and FA have met with ESL Full Time Faculty to discuss forming a department. There
 will be a similar meeting for Short Term Vocational. Faculty still have many questions about how
 chair reassignment will work because classroom hours and load are different in SCE. We are
 tracking down answers, but will fight to ensure that chair expectancies in all areas are treated
 similarly, and have similar implications on release from teaching time.
- The office of instruction has created a class cancellation policy they plan to pilot and will release tomorrow with the beginning of Fall 2025 registration. The FA will monitor the use and effectiveness of this "pilot" and will continue to provide input, guidance and negotiate the impacts of such a policy as we learn more.
- With direction from Executive Board, the FA has filed an association level grievance (Level 3)
 against the district with regard to Article 16.M. We have had the initial meeting on this grievance
 and await the districts response.
- We have conducted the level 4 grievance meeting on a grievance initiated in October regarding scheduling of an adjunct faculty member. We await Dr. Garcia's response within the next week or so
- As you can see, the grievances we are filing are raising to higher levels of process. It is always the intent of Emily and myself to try and resolve grievances at the lowest possible level, without formal process if able, but we will follow the process to ensure that our hard won contract is enforced. Please remind your fellow faculty that if they observe or know about contract violations, either one time or ongoing, to bring FA into the loop so that we can ensure the district adheres to their agreements.

Negotiations Update:

- The FA and District continue to meet on a weekly basis, Fridays from 9:00am 11:00am, and the
 FANT continues to meet weekly on Tuesday's from 3:30 5:30 and Fridays from 11:00am 1:00pm. We have added meetings to our calendars beyond the district's initial projection that
 we would be wrapped up by May 1st.

Governance Committee Update:

- After guidance at the 2.25.25 executive board meeting, the Governance committee met outside
 of regular time on Sunday 3/2/25 from 10:00am 3:00pm to further infuse and codify Part-Time
 roles into the proposed FA governance structure. The committee will be recommending the
 following, as part of the Standing Rules:
 - All FA committees have at least one dedicated seat for Part Time. Committees of 5 or greater membership this PT representation will be increased to 2 members.
 - Additional duties for Executive Board Members, such as chiaring one of the FA standing committees
 - Possible expansion of Executive Board size, with dedicated seats for Full Time & Part Time, as well as "At Large" seats that would be open to either FT or PT
 - Modifying all committee appointments to be recommended by president, and confirmed by the executive board.

Salary and Leaves Update:

- S&L continues to approve PGI and Column Crossover requests on an every other week basis. If you believe you have earned the credit to qualify, please reach out.
- The committee discussed the implications for ranking / scoring applications on an accelerated timeline with a September 1st due date. This was determined to not be feasible for the upcoming year.
