I. Call to Order

President Emily Woolery called the meeting to order at 11:33am.

II. Approval of Agenda with Flexibility

A motion was made to approve the agenda with flexibility, seconded and was carried.

III. Approval of Minutes

A motion was made to approve the September 2, 2025 meeting minutes, seconded and was carried.

IV. Reports

a. President

President Emily Woolery presented and distributed a written <u>report</u> (attached) and distributed an accreditation update report.

b. Vice President

Vice President Joshua Christ presented and distributed a written <u>report</u> (attached) and distributed the amended <u>Standing Rules</u> adopted by the executive board.

c. Treasurer

Treasurer Michelle Nava presented and distributed a written report. Michelle is scheduling appointments with our auditors and preparing for the annual audit.

i. Increase budget for LBGTQ+ Conference

Treasurer Nava reported that the Budget Committee does not recommend an increase to the line item to fully fund the interested members' attendance at the LBGTQ+ Conference being held in Garden Grove, CA. The budget previously approved by Rep Council will cover the conference registration fees for all attendees. Questions were asked by a Council Member about the amount required to fully fund conference attendance and the amount the Association has in reserves. To fully fund conference attendance would require doubling the budget line item, which is an increase of \$3600. The amount in CDs is currently \$285,000. A motion was made to approve an increase of \$3600 to the LBGTQ+ Conference budget (McLaughlin) and seconded (Christ). The motion failed: 19 in favor; 23 opposed; 4 abstained.

V. Negotiations

Year 3 of the 2022-2025 Faculty Contract was approved by the Board of Trustees on October 6, 2025. The FA and the district will be reading the contract for accuracy in mid-October.

VI. Elections

Elections Committee Chair Shari Wasson presented the names of the nominees for Full-time Director (1 seat), Adjunct At-Large Representative (6 seats), and FACCC Designated Representative (1 seat). No additional nominations were made from the floor. A motion was made to close nominations (Wasson) and seconded (Christ). The motion passed: 32 in favor; 1 opposed; 2 abstained.

Elections Chair Wasson announced that candidate statements of no more than 150 words are due October 13 by noon and voting will be held October 20 – 29, 2025. All candidates will be emailed with information about the <u>timeline</u> and CTA rules for campaigning.

VII. Old Business – Action Items

 Support for Bachelor of Science in Nursing (BSN) Degrees at California Community Colleges

A motion was made to send a letter of support on behalf of Mt. SAC Faculty Association (Komrosky) and seconded (Meyer). Representative Joseph Komroskly spoke in support of the motion. Vice President Christ stated that CTA and CCA have a watch position on the bill because the funding for the bill will likely affect K-12 funding. The motion passed: 39 in favor, 2 opposed, 2 abstained.

VIII. New Business - Discussion Items

a. FA Goals

President Emily Woolery presented the item and reviewed the priorities identified by the Executive Board. The Executive Board recommends approval. A question was asked about the process for developing the goals. Emily replied that the goals were based on CTA materials that assist local chapters in assessing areas of strength and those needing improvement. The item will return for action at the next meeting.

IX. Other Reports

- a. Academic Senate: Academic Senate President Tania Anders announced that she encourages faculty to meet with her on Thursdays prior to or after the Academic Senate meeting. The Senate recently passed a resolution in support of an additional hire of classified staff in the FLTC and has drafted a joint resolution joint with the FA in support of hiring faculty.
- b. CCA District M Director: The Fall CCA Conference is this weekend. Joshua will bring back information about any changes to the next meeting. Joshua is concluding his second term as District M Director; the position will open for nominations in January.

1. Faculty Association Contract Ratification Vote

The contract ratification vote closed on Friday, September 26, at 5:00 PM. Contract language changes were approved by 93% of the voters. The contract language changes were approved by the Board of Trustees on October 6.

One challenge was noted in that some members did not find ballots in their email. One member requested a print ballot.

2. Faculty Association Executive Board

The Faculty Association (FA) Executive Board met on September 9, 16, and 30. At these meetings, we:

6. CTA Service Center One Voting Representatives

At the September 30 meeting of CTA Service Center One (SCOne), approval of revised SCOne Rules of Operation reduced the number of voting representatives the FA can elect to SCOne. We will now be able to send the Chapter President and three voting representatives (reduced from four voting representatives). Our current voting representatives are Ken Lambright, Zina McFarlin-Stagg, and Dave Mrofka. We previously announced a fourth seat available for election this semester. Based on this revision, the FA will no longer elect a fourth voting representative.

7. CTA Virtual Town Hall

CTA held a Virtual Town Hall on October 6. The Town Hall included "legal guidance for our rights on the job, our Union's campaign to get out the vote for YES on Prop. 50, key resources to support our immigrant students and families, and our school funding campaign [extension of Prop. 55]." The CTA website (https://www.cta.org/) has a variety of resources. Some resources will require login.

8. Faculty Association of California Community Colleges

Faculty Association of California Community Colleges (FACCC) dues deductions will begin this month. The amount is \$18.90 per month for ten months for full-time members (\$189 annual) and \$5.50 per month for ten months (\$55 annual) for adjunct members.

Membership in FACCC allows the FA to elect one member to serve as our board representative, and we can schedule presentations with FACCC. Ideas for presentations include, but are not limited to, advocacy, board of trustee elections, budget, leadership, legislation, retirement benefits. <u>September 13</u>: The trustees had discussion on many topics: Licensed and Vocational Nursing Program, Histotechnology Bachelor's Degree Program, Equal Employment Opportunity and Health Centered Engagement Training, Preventing Harassment, Discrimination, and Retaliation in the Academic Environment Training, and Welcome Center Overview and Plans.

October 9: The trustees approved the FA's contract language revisions.

10. President's Advisory Council

President's Advisory Council (PAC) met on September 10 and 24. PAC is scheduled to meet next on October 8.

<u>September 10</u>: AP 2015 – Student Member was approved as a final reading. PAC received the 2024-26 Progress Review from the Strong Workforce Advisory Committee, and it received updates from Budget Committee, Climate Commitment and Environmental Justice Committee, DEISA+ Council, and Information Technology Advisory Committee (ITAC). ITAC reported that communication about expected downtime will be increased, and implementation goal completion of multi-factor authentication is October. The Vice President of Student Services reported that the Pride Center has relocated to Building 6, Room 160.

<u>September 24</u>: PAC reviewed <u>BP 6620 – Naming of Buildings</u> as an information item. It was noted that the trustees have interest in securing funding to name buildings. We received updates from Budget Committee, DEISA+ Council, and Facilities Advisory Committee. DEISA+ Council is planning a town hall on November 7. The Academic Senate President requested increase faculty appointments to Facilities Advisory Committee.

Vice President's Report to the Representative Council October 7th, 2025

Negotiations Update:

- Negotiations for the 2024/2025 Year 3 of 3 contract have been ratified by the Faculty
 Association, and were approved by the Board of Trustees at the 10/06/25 meeting
- FANT and District teams will meet to ensure contract is updated with correct language and compensation amounts, and will make the updated contract available as soon as possible.
 Please reach out to Emily or Joshua if you would like a physical copy, as the new FA standard is to disseminate digital copies via email and the website.
- Negotiations are already behind for the full 3 year contract, which should have been agreed to prior to July 1st, 2025. We hope to sunshine articles in November, and begin negotiations in January of 2026.
- There will be a faculty survey being sent out in the next week or so, please encourage ALL
 faculty to respond to this survey. It is how FANT and the FA Executive Board know what to
 prioritize when we get to the table with the district. This is your opportunity to tell us
 what needs to be better about your contract.

Governance Committee Update:

- The Executive board has approved some modifications to the standing rules. The updated standing rules are in the October Rep Council folder for review.
- The Governance Committee continues to work on further updates to the standing rules to best reflect our current practices, and merge previous bylaws into our current standing rules to comply with CTA bylaw requirements.

Other Contract / Working Condition Questions:

- The FA is working on working condition equivalency between matching jobs of credit and noncredit professors. There is no reason the FA sees that these faculty should be working different hours / conditions simply because of their placement.
 - We hope to address this issue with curriculum and senate in the near future.
- Dual Enrollment We have had reports of the high school sites not respecting the class cap. Please ensure that classes within your department are respecting the class caps and our FA Contract within the dual enrollment sites.

CCA Updates:

- CCA Conference is upcoming on October 10-12th, please make your reservations by 10/2/25 if you have not already done so.
- CCA Pre-Conference Delegate Meeting on October 8th; 6:00pm 7:00pm
 - Learn about some of the opportunities and procedures for reimbursement for the conference, as well as what you'll be voting on Sunday morning at CCA Council

 University Credit Program has received an update (according to Sean Mabey, CTA Member Benefits), and CTA members can now complete 6 units per semester, as well as 6 units during the summer, for a total of 18 units during a calendar year (all at no cost to the member)

FACCC Updates:

- FACCC Board of Governors is tentatively in support of CTA Prop 55 extension, but I did not ask them to take a position on it before language was published. General sentiment in the room is full support and signature gathering, if asked, from our CCCI and CFT colleagues.
- I have been appointed chair of the FACCC Political Action Committee, while Drew Aleman will continue to be staff support for that committee
 - FACCC and CTA are both assisting in locating BoT candidates for Mt.SAC races
- Oranit Limmaneeprasert has announced she will be stepping down / resigning as
 FACCC President, effective December 18th, 2025. Sarah Thompson (current FACCC VP) will
 be stepping into the role and completing Oranit's term as president.
- There was a very warm welcome to Mt.SAC as a contract district, and many offers of what FACCC can do for Mt.SAC at the FACCC Board of Governors meeting in September.

CTA Updates:

- CTA encourages a YES on PROP 50 this election cycle:
 - This Trump administration has engaged in the largest attack on working people and unions since Reagan eliminated collective bargaining for the Air Traffic Control. At that time we saw a decrease in worker power from 30% of all working adults in the United States to roughly 10% of working adults now. If this power remains unchecked, and we stand by while this administration steals the midterm elections by gerrymandering districts in states that are Republican controlled, we face two more years of unchecked power and unchecked attacks against working families. In our union halls, hospitals and paychecks. It is likely that our ability to legally unionize relies on the 2026 election cycle, and we cannot sit idly by as other states actively engage in rigging the system against the majority. o PROP 50 only goes into effect if other states gerrymander their districts ahead of the 2026 mid-term election. If Texas (or other republican controlled legislatures) back down, then Prop 50 will have no effect, and our system will remain as it is. The full impact of Prop 50 is as a reaction to other states trying to swing congressional districts into their favor, which would be a detriment to all Californians (as we are not attacked by the federal government based on demographics, but as a whole state).
- CTA has shared that Signature Gathering for Prop 55 Extension will begin in Mid-November, and continue through February.
 - FA Officers will develop a signature gathering plan, and present it to Exec Board at a future meeting. We will need volunteers. The goal is 85% of membership (roughly 825 signatures from members), and the stretch goal is to get our community signatures as well.
